## Show Rules for Craft & Flea Market Vendors

Set up times: Saturday starting at 6:00 am..

Show hours; Saturday 9 am till 5 pm, for side street vendors.

Booth Rental Fee for Craft & Flea Market Vendors will be \$20.00 for approx. 10 feet of frontage space

Electrical outlets will not be available for craft & flea market vendors. Generators will not be permitted.

**NO VENDOR WILL MODIFY ANY VILLAGE OF OBLONG ELECTRICAL CONNECTION.**

Booth Rental Fee for Church, School or Not-For-Profit Groups, FREE 10 foot (approx.) booth.

**\*Merchandise Vendors MUST be off Main Street sidewalks by 5:00 pm Saturday.**

**\*Merchandise Vendors on South Range Street MUST be off by 10:00 pm**

1. Reservations and full payment must be received by Oct. 15, 2018. After Oct. 15, 2018 booth space will not be guaranteed. *There will be no refunds after reservations are accepted.*

2. **NO Homemade Jams, Jellies, Pickles or Home Canned Food Allowed per Crawford County Health Dept.** Packaged Breads, Cookies, Noodles and Candy may be sold. Only food vendors may sell other foods.

3. No merchandise will be displayed or sold which is not suitable for a family festival. Exhibitors will not display or sell any items objectionable to the show committee.

4. **NO ALCOHOL OR DRUGS WILL BE ALLOWED. NO ILLEGAL ITEMS WILL BE SOLD.** Any infraction of this rule will result in immediate eviction from the show. Law enforcement officers will be present.

5. **We frequently empty the trash barrels. If you have any items that need to be disposed of during the day from the course of operating your booth, it is your responsibility to get them to the dumpster. There will be NO stuffing of the trash barrels with trash from your booth during the day.**

**These barrels are for YOUR CUSTOMERS.**

6. There will be no subletting of spaces permitted. If there is more than one person sharing a space, all names must be on the reservation.

7. The committee reserves the right to accept or reject any exhibitor and to assign spaces. We also reserve the right to ask the participant to leave without refund if a disagreement results over the location of booth space, or if a participant abuses the rules.

8. You will be responsible for your own security. We will not be responsible for any lost, stolen or damaged property.
