Show Rules

Set up times Friday, Oct. 29, 2010, after 5:30 pm for professional food vendors on South Range Street.
Saturday, Oct. 30 will be 8 am.

Show hours Saturday 9 am till 5 pm, for side street vendors.

Booth Rental Fee for Flea Market Vendors, \$2.00 per frontage foot, with a \$15 minimum.

Electrical outlets will not be available.

Booth Rental Fee for Professional Food Vendors, \$150.00 per booth, includes electric.

NO VENDOR WILL MODIFY ANY VILLAGE OF OBLONG ELECTRICAL CONNECTION.

Booth Rental Fee for Church or School or Not-For-Profit Groups, FREE 10 x 10 (approx.) booth.

All Merchandise Vendors MUST be off streets & sidewalks by 5:00 pm Saturday

Food Booth vendors MUST be off South Range Street by 10:00 PM Saturday.

1. Reservations and full payment must be received by Oct. 15, 2010. After Oct. 15, 2010 booth space will not be guaranteed. *There will be no refunds after reservations are accepted.*

2. **NO Homemade Jams, Jellies, Pickles or Home Canned Food Allowed per Crawford County Health Dept.** Packaged Breads, Cookies, Noodles and Candy may be sold. Only food vendors may sell other foods.

3. No merchandise will be displayed or sold which is not suitable for a family festival. Exhibitors will not display or sell any items objectionable to the show committee.

4. **NO ALCOHOL OR DRUGS WILL BE ALLOWED. NO ILLEGAL ITEMS WILL BE SOLD.** Any infraction of this rule will result in immediate eviction from the show. Law enforcement officers will be present.

5. **Food Vendors bring at least 150 feet of # 10 wire cord or larger diameter. None will be supplied by the show.**

6. **We frequently empty the trash barrels. If you have any items that need to be disposed of during the day from the course of operating your booth, it is your responsibility to get them to the dumpster. There will be NO stuffing of the trash barrels with trash from your booth during the day.**

These barrels are for YOUR CUSTOMERS.

7. **All food vendors will have waste water holding tanks. There will be NO DUMPING of GRAY WATER on the public streets.**

8. There will be no subletting of spaces permitted. If there is more than one person sharing a space, all names must be on the reservation.

9. The committee reserves the right to accept or reject any exhibitor and to assign spaces. We also reserve the right to ask the participant to leave without refund if a disagreement results over the location of booth space, or if a participant abuses the rules.

10. You will be responsible for your own security. We will not be responsible for any lost, stolen or damaged property.
